For four years, whilst continuing to serve you on the Town Council, I have watched the services provided by the District Council deteriorate under the current Labour, Green and Independent administration.

Our local car parks no longer provide that vital free one-hour parking. This was always a major benefit for local businesses and residents and its loss has increased the pressure on parking in the High Street. Stourport High Street was already struggling with increased congestion due to illegal parking – with little enforcement from the District Council – and all of these bad decisions have contributed to an increase in the pollution around York Street. So, your local Conservative team is committed to increasing enforcement and returning the free one-hour parking to a car park in Stourport.

As many of you will know, as a Town Councillor I did not support the badly conceived planning application for the Bridge Street Car Park and as your District Councillor I will fight for this to be developed as a mixed-use site.
